Residuary bequest (a proportion of your estate)

I give (%) of the residue of my real and personal estate which I can dispose of by Will in any manner I think proper to Chipembele Wildlife Education Trust (Zambia), registered number 41437 and the receipt of the Honorary Treasurer or the proper officer for the time being of Chipembele Wildlife Education Trust (Zambia) shall be a complete discharge to my executors.

Pecuniary bequest (a set sum)

I give the sum of Chipembele Wildlife Education Trust (Zambia), registered number 41437 and the receipt of the Honorary Treasurer or other proper officer for the time being of Chipembele Wildlife Education Trust (Zambia) shall be a complete discharge to my executors.

or

I give to Chipembele Wildlife Education Trust – (Zambia) registered number 41437 for the purposes of: (choose one below or leave all below)

1.1 *for its general purposes*

1.2 *for its Wildlife and Conservation Education Classes*

1.3 *for its Conservation Education in School Outreach Programme*

1.4 *Other (specify)*

2. *I declare that the receipt of the secretary, treasurer or other proper officer of the nominated beneficiary will be a full discharge for my trustee who will not be bound to see its application.*

Specific legacy bequest (a named item)

I, give to Chipembele Wildlife Education Trust (Zambia), registered number 41437, absolutely, my (name and description of item).

Additional Paragraphs

These additional words in relation to the bequest will see the amount/asset/goods you intend to gift to Chipembele Wildlife Education Trust still come to Chipembele Wildlife Trust (Zambia) intended projects and programmes should our operations continue with a change of name and/or charity number change or in the case of a merger with another wildlife organisation.

"If at my death any charity named as a beneficiary in this Will or any Codicil hereto has

changed its name or amalgamated with or transferred its assets to another body then my executors shall give effect to any gift made to such charity as if it had been made (in the first case) to the body in its changed name or (in the second place) to the body which results from such amalgamation or to which such transfer has been made."

If you wish the bequest to be used for Wildlife Education or Wildlife Protection in Zambia and Chipembele Wildlife Education Trust (Zambia) has dissolved at the time of your death, you may also say.

"In the event this charity Chipembele Wildlife Education Trust –(Zambia) named as beneficiary in this will or codicil has dissolved at the time of my death. My intention is this amount/asset/goods be bequeathed to a similar organisation active in Wildlife Education or Wildlife Protection in the South Luangwa Valley, Zambia at the discretion of my executor and the receipt of the Honorary Treasurer or other proper officer of the recipient organisation for the time being shall be a complete discharge to my executors."
